

Terms & Conditions – Buyback offer BE 6 Batman Edition 2025 (“Offer”)

- 1) This buyback option is available exclusively to the original registered owner of the BE 6 Batman Edition vehicle (“**Vehicle**”) purchased directly from an authorised dealer of MEAL. This offer is non-transferable and cannot be availed by subsequent owners.
- 2) This Offer is valid only up to 30 days from the date of communication. Requests received after this period will not be eligible for this Offer.
- 3) The buy-back price (“**Offer Amount**”) shall include original ex-showroom price, registration charges, road tax, standard insurance (as originally invoiced) and Mahindra genuine accessories invoiced at the time of original purchase of the Vehicle, supported by original copies.
- 4) The Offer Amount shall exclude any extended warranties, service packages or add-on covers purchased separately, personalised or premium registration numbers, all aftermarket additions or modifications (including paint protection film, ceramic coating, wraps, repainting or non-standard accessories), any financing costs such as interest or EMIs, any insurance claims, benefits or depreciation-related considerations, and any other claims whatsoever pertaining to the Vehicle or otherwise.
- 5) The Offer Amount shall be payable only if the Vehicle is returned to MEAL in complete and roadworthy condition, subject to normal wear and tear, with all original features intact, free from structural, flood, or total loss damage, without any missing parts or non-standard modifications, along with all original keys, documents, manuals, and accessories.
- 6) MEAL reserves the right to inspect the Vehicle and, in case of any damage, missing items, non-intact features, or deviation from the expected condition, adjust the buyback value or decline the request.
- 7) The Vehicle must have a clear and marketable title, free from any encumbrances, hypothecation, or legal disputes. In case of an active loan, the loan must be fully closed prior to or at the time of buyback, as per process defined by MEAL.
- 8) At the time of handover of the Vehicle to MEAL / its Authorised Dealer under this Offer, the Vehicle shall be clear of any e-challans or traffic violations against it from any authority or otherwise.
- 9) The Offer Amount shall be paid as a one-time, full and final settlement in respect of all claims, demands, or liabilities arising out of or in connection with the purchase, ownership, use, and buyback of the concerned Vehicle, and upon receipt of the Offer Amount, the customer shall not be entitled to, and MEAL shall not be liable for, any further claim of whatsoever nature in relation to the said Vehicle, and the customer irrevocably agrees not to raise any further claims,

demands, or proceedings against MEAL or any of its affiliates or dealers in this regard.

- 10) The Offer Amount shall be paid to the same bank account from which the original payment was made (or as otherwise validated by MEAL) within 30 working days from the successful Vehicle inspection, submission of all required documents, and completion of ownership transfer formalities. At the said time, the customer shall also be required to furnish a declaration to the effect that he / she has received the offer amount being the full and final settlement towards the sale of the said Vehicle and shall not have any further claims whatsoever in respect of the said Vehicle against MEAL and / or its Authorised Dealer/affiliates.
- 11) The customer shall continue to be liable for liabilities of any nature created in respect of the said Vehicle up to the date of buy back of the Vehicle by MEAL. It is clarified that MEAL and its affiliates shall stand indemnified by the customer in respect of any such liability or otherwise.
- 12) Once the Offer Amount is paid to the customer, MEAL shall have sole discretion to deal with the bought back Vehicle in any manner it deems fit and the customer shall not have any objections whatsoever in respect of the same.
- 13) MEAL reserves the right to verify all submitted documents and details, accept or reject any request not meeting the prescribed criteria, and modify the process requirements for operational reasons, and this offer is a one-time option for the specific programme and shall not be treated as a precedent for any other product or customer.
- 14) All matters arising out of this Offer shall be subject to the jurisdiction of courts at Mumbai.
